

WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way arising from the use and condition of an ice hockey rink and related events and activities regarding same, the undersigned acknowledges, appreciates, and agrees and warrants that:

- 1) The risk of injury from the activities involved in this program is significant and the participant ACKNOWLEDGES THAT ICE IS VERY SLIPPERY AND, DEPENDING UPON INDIVIDUAL SKILL AND EXPERIENCE LEVEL, ICE SKATING & ICE HOCKEY MAY INVOLVE FALLS UPON THE ICE, COLLISIONS WITH OTHER SKATERS, COLLISIONS WITH OBJECTS SUCH AS STICKS, SKATES AND PUCKS OR OTHER STRUCTURES, AND MAY THEREFORE BE CONSIDERED A HAZARDOUS ACTIVITY WHICH SKATER/RELEASOR HAS ELECTED TO VOLUNTARILY PARTICIPATE, WITH FULL KNOWLEDGE, ACCEPTANCE AND ASSUMPTION OF ANY AND ALL RISKS OF SERIOUS PERSONAL INJURY, DEATH OR PROPERTY DAMAGE.
2. SKATER/RELEASOR warrants that SKATER/RELEASOR'S minor child(ren) (where applicable) between the ages of six (6) and twelve (12) must be supervised at all times by a parent, legal guardian or designated supervising adult, who must remain in the immediate skating rink at all times while child(ren), minors are skating.
3. SKATER/RELEASOR further warrants that neither SKATER/RELEASOR nor his/her children have no known medical conditions or disabilities which may be incompatible with the safe participation in ICE SKATING & ICE HOCKEY. PARTICIPATORS under the age of 6 must at all times be THE RESPONSIBILITY OF AND ACCOMPANIED BY a parent or legal guardian while on ice skating rink.
4. SKATER/RELEASOR knowingly and freely ASSUMES ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for Skater/Releasor's participation; and,
5. SKATER/RELEASOR willingly agrees to comply with the stated and customary terms and conditions for participation. If, however, Skater/Releasor observes any unusual

significant hazard during Skater/Releasor's presence or participation, Skater/Releasor will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,

6. SKATER/RELEASOR for himself/herself, and on behalf of his/her heirs, assigns, personal representatives and next of kin, HEREBY RELEASES AND HOLD HARMLESS Todd & Kim Churchill, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE CAREFULLY READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
